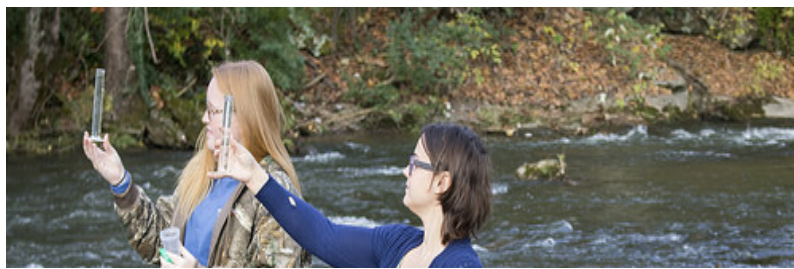

MAERDAF Spotlight - Hagerstown Community College receives a Maryland Agricultural Education and Rural Development Assistance Fund (MAERDAF) grant for their new environmental studies program

[Hagerstown Community College](#) recently received a grant from the Maryland Agricultural Education and Rural Development Assistance Fund, or MAERDAF, administered by the Rural Maryland Council, to hire an assistant to help support the development of the new environmental-studies program.



The MAERDAF grant will be used to fund a part-time recruiter/curriculum development assistant to work with lead faculty to help recruit students for the new environmental-studies program, assist with the planning of a summer institute for K-12 teachers, and help develop collaborative relationships with community partners.
