Chair Scott Warner called the meeting to order at 12:10pm.

Chair Warner and Executive Director Charlotte Davis acknowledged elected and state agency officials.

Minutes

The Board reviewed the minutes from the November 29, 2018 Rural Maryland Council Annual and Executive Board Meeting. No comments or suggestions for revisions were made. A motion was made by Josh Hastings to accept the minutes. The motion was seconded by Commissioner Wilbur Levengood, and all were in favor. The minutes from the November 29, 2018 Rural Maryland Council Annual and Executive Board meeting were accepted unanimously.

Guest Speakers

United States Senator Chris Van Hollen

Senator Van Hollen discussed key highlights from the Farm Bill including increased federal funds and a change in the funding formula to provide continued support for the Rural Conservation Program, and increased funding for rural broadband expansion. Senator Van Hollen also discussed the urgency to respond to the opioid epidemic, and the need to provide more resources and investment to modernize infrastructure in rural communities.

Ms. Ashley Biggs, Outreach Librarian, Maryland State Library for the Blind and Physically Handicapped Ms. Biggs provided an overview of the Maryland State Library for the Blind and Physically Handicapped, and the resources available to assist individuals residing in rural communities. Ms. Biggs presented specialized equipment and services available for rental through the agency for rural communities.

Mr. Jack Reitnauer, Warwick Mushroom Farms

Mr. Reitnauer presented information on the Warwick Mushroom Farm facility located in Cecil County, the operations of the facility, and the process for cultivating large varieties of mushrooms for retail.

Committee Reports

Financial

Charlotte Davis presented the FY2019 Budget as of December 21, 2018. The Rural Maryland Council has total operating available revenue of \$375,651.94, and a total of \$5,425,872.55 in grant expenditures. Charlotte Davis requested questions regarding the budget, no requests for questions were made.

Rural Maryland Prosperity Investment Fund (RMPIF)

Chair Scott Warner shared that the FY2020 Administrative Budget released by Governor Hogan on January 18, 2019 included \$6million for RMPIF. Copies of the press release announcing the funding were provided. Chair Warner expressed thanks on behalf of the Rural Maryland Council to Governor Hogan and his administration for funding support.

Legislative

Legislative Committee Co-Chairs Lindsay Thompson and Odette Ramos provided the update. Copies of the 2019 Legislative Priorities were provided. The Rural Maryland Council Legislative Committee will next meet on January 28, 2019 via conference call at 3pm. Rural Maryland Day is scheduled for February 14, 2019.

Rural Maryland Foundation (RMF)

President Dan Rider provided an update of the RMF. President Rider shared that the Rural Maryland Philanthropic Development Strategies report has been finalized, copies were made available. The Aspire Rural Version 2.0 video will continue to be revised. The RMF will also be providing a biannual scholarship contribution of \$5,000.00 to the LEAD Maryland Foundation to support tuition for LEAD Fellows.

Agriculture

Agriculture Committee Chair Erroll Mattox, provided an update. Chair Mattox shared that industrial hemp will be a major topic during the 2019 Legislative Session, and encouraged interested attendees to join the Committee.

Joint Planning and Development

Joint Planning and Development Chair Mike Thielke was unavailable; Charlotte Davis provided an update. The Joint Planning and Development Committee will meet via conference call on February 25, 2019 to discuss the FY2020 work plan.

Executive Director's Report

Charlotte Davis shared that the Rural Maryland Council has reconvened the Rural Summit Planning Committee to plan for the 2019 Rural Summit on December 12th. The Rural Summit Planning Committee will meet via conference call on January 31st at 10am-11am. Sign-up sheets to participate on the Summit Planning Committee were made available. The Rural Maryland Council recently submitted the Task Force for Rural Broadband Recommendations Report in mid-January. The Council is currently planning for Rural Maryland Day on February 14, 2019, sign-up sheets were made available. Copies of the Rural Maryland Council staff activity reports were made available.

Chair Warner requested announcements from attendees. With no other business to discuss, Chair Warner requested a motion to adjourn the meeting. The motion to adjourn was approved unanimously. The meeting adjourned at 1:45pm.
