## Current OSB Programs

- Connect Maryland: Network Infrastructure
  - Fund broadband Infrastructure Deployment
- Neighborhood Connect
  - Funds expansion of existing broadband networks into neighborhoods lacking service
- Connected Communities
  - Funds networks that provide free or very low cost service to covered populations
- Digital Inclusion
  - Funds education related programs to expand the use of broadband
- Maryland Emergency Broadband Benefit
  - Provides up to a \$15 per month subsidy to eligible subscribers for broadband service
- Device Subsidy
  - Provides a free laptop to eligible households

## Upcoming Programs

2 programs expected this summer

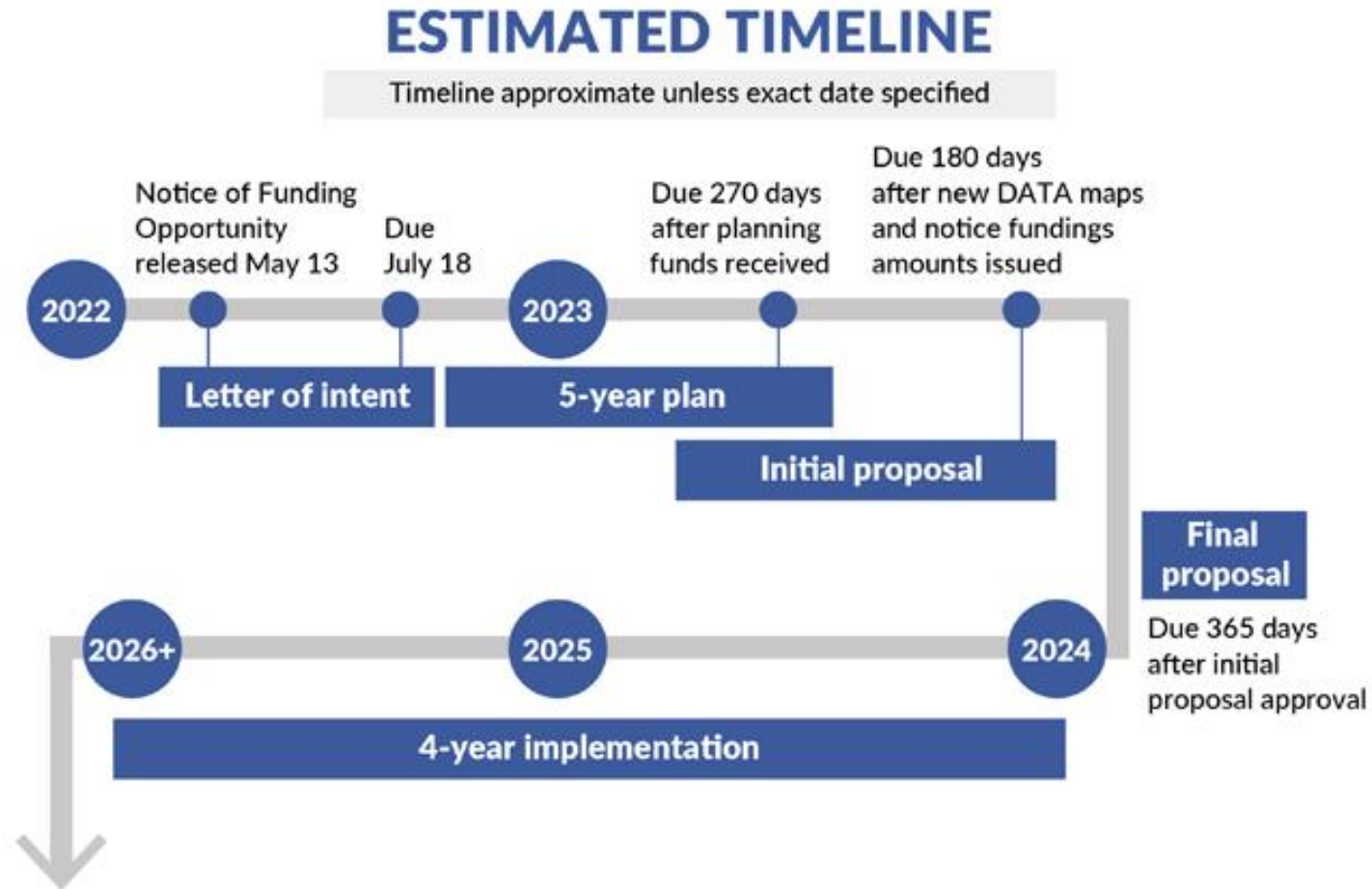
- Broadband for Public Housing
  - Will provide funding to wire public housing units lacking a broadband connection
- Broadband for Difficult to Serve Premises
  - Will provide grants to counties to help individual properties lacking broadband due to excessive costs for deployment
- Plus a second round of device grants

## Broadband Equity Access and Deployment (BEAD)

- \$42.5 Billion program being managed by the Federal Department of Commerce, National Telecommunications Information Administration (NTIA)
  - Each state will receive a minimum of \$100 Million
  - Final amounts will be determined by a ratio of the number of unserved locations in the state vs. the US
  - Requires a broadband plan with a 5 year implementation plan
    - MD received \$5 Million to create and implement the plan
  - Requires community outreach and engagement
  - Requires a workforce development plan



## BEAD Timeline



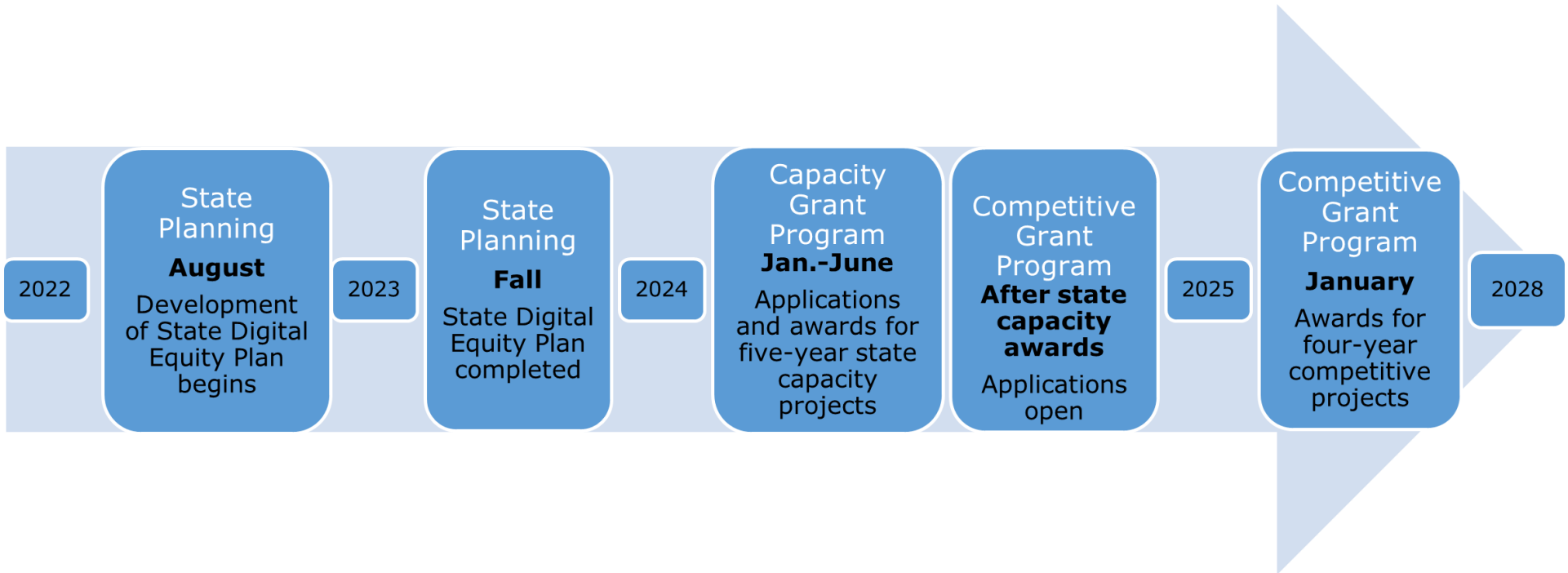

## Digital Equity Act

- \$2.75 Billion program being managed by the Federal Department of Commerce, National Telecommunications Information Administration (NTIA)
  - Creates 3 programs
    - \$600 Million for planning – MD received \$966,000
      - Requires a 5 year DE plan
    - \$1.44 Billion for implementation
      - Amounts based on formula for plan implementation
    - \$1.25 Billion for a competitive grant programs
- NTIA has just published the draft regulations for these programs and is accepting comments through May 1, 2023.
