Ms. Charlotte Davis welcomed everyone and convened the meeting at 11:03am. Ms. Davis stated that a group was convened at the last Summit and one of the outcomes was to reconvene the rural housing committee. Ms. Davis further stated that the purpose of the meeting was to review the Committee's mission, vision, and start to get some ideas on what the Committee should be doing. Introductions were made among participants.

The Committee reviewed the meeting materials that were sent to all the participants on 2/22/2203. Ms. Davis reviewed the purpose of the Committee and potential outcomes. Members discussion included the following:

- Convene and engage stakeholders and the appropriate members in the legislature.
- Invite the Maryland Board of Realtors as they recently completed a research report about the affordable housing issues.
- DHCD initiative to provide shelter for as a basic human right and expanding affordable housing. It was recommended to have a meeting with Secretary Jake Day. Ms. Davis stated that the Council has a meeting with the Secretary to talk about broadband and she will plan to engage him about housing as well.
- Social determinants of health need to be on the agenda because the interconnectedness and the future use of funding will be very important, especially the intersection between housing and health.
- Focus on market rate housing and the challenges related to the labor source and the attraction of talent.
- Invite Lance George, Resource Director at <u>Home Housing Assistance Council</u> (<u>ruralhome.org</u>) to the meeting.
- Invite USDA MD/DE office to participate in the group.
- Look at existing programs and what's working/what's not develop an inventory.
- Bring someone from the housing community to learn about obstacles they are running in to An example given is LifeStyles Homeless Center which is a former hotel being converted to transitional housing in southern Maryland.

- Develop an innovative housing idea that can be funded through Foundation work and used as a project to highlight this important work.
- Take a more aggressive approach to increase dollars toward affordable housing.
- Terminology used describe the type of housing and being aware of what affordable housing is and what it is not. Workforce housing, affordable housing should be using affordable workforce housing. It was suggested to use photos to show that workforce housing looks like market rate housing.
- Are there resources available that focus on livable communities that are based on the human needs of the community, not just a driver of wealth. A process or culture where everybody counts.
- Summit ideas for keynote speakers considerations that focus on housing.
