A. Call to Order 12:26 p.m.

B. Review of April 15, 2024, Minutes

1. Motion to approve minutes made by Steve McHenry and seconded by Gregory Padgham.

C. Speaker – Delegate Jeff Ghrist

Delegate Ghrist provided an overview of recent budget cuts and their implications for the administration's priorities as we approach the next legislative session. During the discussion, committee members expressed a shared interest in examining the processes of the Board of Public Works before the upcoming session. It was noted that the state is facing a structural deficit of over four billion dollars, with the Kirwan program being a significant contributing factor. Overall, the discussion emphasized the importance of fostering bipartisan partnerships and conversations to strengthen connections for the RMC's priorities in the next legislative session, including the RMC budget.

D. Interim Legislation Topics

- 1. SDAT Legislation
 - i. Thompson: overview on history of current SDAT legislation and the most recent session, interagency problems with communication led to withdrawal status for bill
 - ii. Teffeau: New SDAT Director and Assistant Director. Suggesting the Agriculture Committee do some outreach to them in how we can assist in this problem. No SDAT representative at GICA meetings, and it is not on agendas that have been seen as of now. Going to follow up with MDA Secretary regarding GICA requests.

2. Rural Housing

- i. Davis: providing update on the current state of the Housing Committee. Looking at local zonings and inclusionary zonings that will benefit rural communities.
- ii. The challenge is that part of this comes down to the local areas.

3. State Fair

i. Helping state board fairs look at their deficit they are operating under. Charging an extra dollar in admissions could help mitigate these issues.

4. Cooperative Development

i. We are supporting SB85, a worker cooperative bill, and are exploring ways to gain support for this legislation this year, likely through crossfiling.

 - v. Looking to reach out to the Comptroller regarding these ideas and if this would implement the same amount of funding or has too much changed since the fiscal note is over a decade old.
