



<u>Emergency Housing Rehabilitation Program</u> – provides zero percent interest, deferred loans to households under 70% AMI for emergency items in eminent need of repair and correction of health and safety code items

- May re-apply after 2 years
- Due when property is sold, refinanced or transfer title of property
- Loan amounts of up to \$15,000

<u>Senior Housing Rehabilitation Grant Program</u> – provides grants to senior homeowners under 30% AMI for emergency home repairs, correct substandard conditions, or to make accessible, health and safety modifications to aid in remaining in home for longer period of time.

- One occupant must be 55 or older
- Must not have received grant funds in last 5 years may be reconsidered in emergency conditions
- Maximum grant amount of \$15,000

<u>Community Development Block Grant Funds</u> - Emergency accessibility improvements for low to moderate income homeowners

DHCD Special Loan Programs

<u>Building Community</u> Together - Focus group meets bimonthly involves staff from County and Frederick City housing, Habitat for Humanity, United Way, Health Dept., and Office of Sustainability

<u>Bell Court Senior Apartments</u> – 28 units located in Woodsboro for seniors 62 or older

- Income 30% AMI and below; rents kept at 30% of income
- Owned and managed by the County
- Waitlist currently closed
- Typically only 1-2 vacancies per year

Proactive Programs

Third Party Notification Program

- Permits an older adult, or individual with a disability to designate a third party to receive copies of their real estate tax bill
- Third party agrees to check on the property owner to be sure that the tax notices have been received and encourages prompt payment

THIRD PARTY NOTIFICATION FOR REAL PROPERTY TAXES FACT SHEET Due Date: June 1 before the tax year that begins July 1

DEAR TAXPAYER:

If you are a senior citizen, aged 65 years or older, or if you have a physical or developmental disability, this is your opportunity to participate in a pilot program, where you may designate an adult third party to receive copies of your real estate tax bills, including any notices of unpaid taxes on your **principal residence**.

Frederick County is pleased to offer the benefits of the third party notification program to eligible taxpayers free of charge. Although you can apply any time during the year, you must allow at least 30 days for the application to be processed.

In order to request that duplicate tax bills be mailed to third party designees in time for the annual July 1 real estate tax billing period, eligible property owners must file a complete application by the preceding June 1.

For more details, please refer to the eligibility requirements and follow the application instructions provided below.

WHO IS ELIGIBLE?

Owners of residential real property that is used as their principal residence, who are either:

- a) at least 65 years of age, or
- b) disabled by a physical or mental impairment which substantially limits one or more of their major life activities.

WHEN MUST I APPLY?

You can apply any time during the year, but allow 30 days for the application to be processed. However, if you would like a third party to receive a copy of the July 1 Real Estate Taxes and Fees bill, please make certain to file your application by June 1.

WHOM MAY I CHOOSE AS MY THIRD PARTY DESIGNEE?

Any adult who consents to your designation, such as a friend or relative.

HOW DOES A THIRD PARTY DESIGNEE SHOW CONSENT?

By signing your application form in the appropriate blank.

MUST I APPLY EACH YEAR?

No. Once you apply, the duplicate bills/notices will be sent to your designee unless you advise the Treasury Department that the practice should stop.

If the information relating to your third party designee changes, you will need to complete a new application and submit to the Treasury Department.

HOW DO I APPLY?

Complete the Application for Third Party Notification of Real Property Taxes and mail it to the following:

ARE THERE FINANCIAL RISKS INVOLVED IN AGREEING TO BE A THIRD PARTY DESIGNEE?

No. The third party designee is under no legal obligation with respect to the bill or notice.
