

RMC Legislative Committee Meeting Minutes January 27, 2025 2:00 pm to 3:00 pm Zoom

Co-Chair Kurt Fuchs welcomed committee members and initiated the meeting at 2:03 pm. The committee reviewed the minutes of the January 6, 2025, meeting. Bill Valentine motioned to approve the minutes; Bob Zimberoff seconded the motion. The minutes were unanimously approved.

The committee reviewed Fiscal Briefing Materials, and discussed cuts in the FY2026 budget. For FY2026, RMC has been reduced to \$6 million; MAERDAF has been reduced to \$118,485; the Regional Councils have been \$200,000 each; SMADC has been reduced to \$750,000; and MARBIDCO has been reduced to - \$300,000. RMC is scheduled to attend the Senate Budget Hearing on 2/13, and the House Budget Hearing on 2/17.
